## 4. FIRST AID MEASURES

**Eye:** Immediately flush eyes with plenty of water for 15-20 minutes while holding the eyelids apart. Remove contact lenses, if present and easy to do after the first 5 minutes. Continue flushing. Get medical attention if irritation persists.

**Skin:** Remove contaminated clothing. Wash skin with soap and water. Get medical attention if irritation or other symptoms occur. Launder clothing before re-use.

**Ingestion:** Do not induce vomiting unless directed to do so by medical personnel. If conscious, rinse mouth with a small amount of water and give one glass of water to dilute. Never give anything by mouth to an unconscious or drowsy person. Call a poison center or doctor for treatment advice.

**Most Important Symptoms:** May cause moderate eye irritation. May cause mild skin irritation. Inhalation of vapors or mists may cause mucous membrane and respiratory irritation. If swallowed, may cause intestinal irritation and discomfort and other toxic effects such as dizziness, headache, nausea, and muscle twitching. Contains n-methyl-2-pyrrolidone which may cause adverse reproductive effects.

**Indication of immediate medical attention/special treatment:** Immediate medical attention is recommended for ingestion.

## 5. FIRE FIGHTING MEASURES

**Suitable (and Unsuitable) Extinguishing Media:** Use water fog, alcohol foam, carbon dioxide or dry chemical to extinguish a fire involving this product. Do not use solid water stream as this may spread the fire. **Specific hazards arising from the chemical:** Combustible liquid and vapor. This product will burn in a fire or when heated above the flashpoint. Combustible vapors may collect in low areas. Combustion products include oxides of nitrogen, carbon oxides, hydrogen chloride and hydrogen cyanide.

## 6. ACCIDENTAL RELEASE MEASURES

**Personal Precautions, Protective Equipment, and Emergency Procedures:** Wear appropriate protective clothing and eye protection. Ventilate area. Eliminate all ignition sources.

**Methods and Materials for Containment and Cleaning Up:** Contain and absorb with an inert, non-combustible material such as earth, sand, inert binder or vermiculite. **Mobility in Soil:** Permethrin binds to soil. Imidacloprid has a moderate binding affinity to soil.

**Other Adverse Effects:** This pesticide is extremely toxic to aquatic organisms, including fish and invertebrates. Do not add directly to water. Do not contaminate water when disposing of product or packaging.
